- **Camp is for students entering grades 2-8 and will be held at Mitchell at the Middle, which is 166 Mount Prospect Street in Bridgewater.**
- **Camp Hours are 8:30-2:30**
- **Camp counselors are highly qualified teachers and coaches.**
- **Camp activities include basketball, baseball/softball, soccer, floor hockey, tennis, and fitness games/activities. There will also be a water/snack break every morning, as well as a 45 minute lunch period.**
- **Campers will be grouped by age.**

What to bring:

- **Sneakers, shin pads for soccer, baseball/softball glove, and a water bottle.**
- **Mouth guards are mandatory for floor hockey. Helmets will be provided for any student with no mouth guard.**
- **Campers should bring their own snacks, drinks, and lunches. Please be aware that there will be campers that have peanut allergies.**
